Visa requirements in Hong Kong for hiring overseas employees

As Hong Kong is a multi-national city, it is not unusual for companies to hire professionals from overseas. It is important for employers to understand the visa requirements in Hong Kong as penalties are severe for employers convicted of employing a person not lawfully employable. In this seminar, we will go through the different types of visas issued by the Immigration so that you could apply for the appropriate visa for your overseas employees.

Rental reimbursement program

Hong Kong is also one of the most expensive cities in the world to buy or rent an apartment and therefore, it is common for employers in Hong Kong to provide housing subsidy to its senior executives, including staff hired from overseas. The housing subsidy can be structured in a Salaries Tax friendly manner and could increase the after-tax pay for the relevant employee. In this seminar, we will review the statute law, the landmark court case as well as two board of review cases that may affect the taxation of housing benefits provided by your company.
